FEE AGREEMENT & REFUND POLICY

The practice of Family & Children's Agency is to charge fees at each interval of the adoption process. If the adoption is, for any reason, discontinued, fees paid or incurred for services rendered up to the date of discontinuance shall not be recoverable and shall remain the obligation of the Adoptive Parent(s). Adoptive Parent(s) may only request a refund for fees paid if services have not yet been provided. Any requests for refunds must be made in writing. The Adoptive Parent(s) agree to pay all fees to Family and Children's Agency within thirty (30) days of the date they receive an invoice for services .
